Rates to apply from **April 1**<sup>st</sup> **2016** unless and until amended pursuant to the terms of the Agreement and/or Licences. All prices exclude VAT, which is payable in addition where applicable

## **Service Fees**

For Links and Text Extracts that are delivered under the eClips Web Database Licence, the fee per Link will be:

- 6.3 pence for the first Link sent to the first Permitted User at a Client or a prospective Client (Existing Licensees)
- 9.5 pence for the first Link sent to the first Permitted User at a Client or a prospective Client (New Licensees)

For offline digital Web Articles that are sourced using the eClips Web Database, the fee per Web Article will be:

• 11.2 pence for each Web Article made available to a Client or a Prospective Client

For Paper Copies of Web Articles that are sourced using the eClips Web Database, the fee per Paper Copy will be:

• 4.5 pence for all Paper Copies delivered to a Client or prospective Client
