Rates to apply from **April 1st 2015** unless and until amended pursuant to the terms of the Agreement and/or Licences. All prices exclude VAT, which is payable in addition where applicable

Capitalised terms have the meanings given to them in the eClips Web Database Licence unless otherwise stated.

1. eClips Web Core Repertoire

* The total "Annual Per Title Fee" payable is calculated by counting the number of websites included in each Package and multiplying the total by the relevant "Annual Per Title Fee".

Example: For a Package including 132 websites, for 1-20 clients the fee will be: £59 x 132 = £7,788 per annum.

Service Fees

For Links and Text Extracts that are delivered under the eClips Web Database Licence, the fee per Link for newspapers will be:

- 5.3 pence for the first newspaper link sent to the first Permitted User at a Client or a prospective Client (Existing Licensees)
- 8.1 pence for the first newspaper link sent to the first Permitted User at a Client or a prospective Client (New Licensees)

For Links and Text Extracts that are delivered under the eClips Web Database Licence, the fee per Link for magazines will be:

- 11 pence for the first magazine link sent to the first Permitted User at a Client or prospective Client (Existing Licensees)
- 11 pence for the first magazine link sent to the first Permitted User at a Client or a prospective Client (New Licensees)

For offline digital Web Articles that are sourced using the eClips Web Database (newspaper and magazine), the fee per Web Article will be:

- 11 pence for each Web Article made available to a Client or a Prospective Client

For Paper Copies of newspaper Web Articles that are sourced using the eClips Web Database, the fee per Paper Copy will be:

- 4.4 pence for all newspaper Paper Copies delivered to a Client or prospective Client

For Paper Copies of magazine Web Articles that are sourced using the eClips Web Database, the fee per Paper Copy will be:

- 11 pence for all magazine Paper Copies delivered to a Client or prospective Client

4. **Audit Fee**

A fee is payable to cover audit costs as follows:

MMO turnover (exclusive of VAT)	Monthly Fee £
up to £999,999	£166.66
£1m - £2,999,999	£250.00
£3m - £4,999,999	£333.33
£5,000,000 +	£500.00

NB: If you pay an Audit fee under the NLA MMO Licence or the Web Database Licence the above charges will not apply.

5. **Default Fee**

In respect of the each Licence, you will pay us fees set out in the Fee Tariff in force during the period of that Licence, together with the audit fee and where applicable, the scanning fee and the default charge set out in the Fee Tariff in force during the period of that Licence.
