

## NLA Media Monitoring Licence Fee Tariff 2024

Rates to apply from **April 1<sup>st</sup> 2024** unless and until amended pursuant to the terms of the Agreement and/or Licences. All prices exclude VAT, which is payable in addition where applicable.

Capitalised terms have the meanings given to them in the MMO Licence unless otherwise stated.

All Fees are payable in monthly instalments.

### 1. PAPER LICENCE

The fees per Copy delivered to a Client or prospective Client are as follows:

- 6.5 pence for all UK Newspaper and Newspaper Websites and standard Magazine and Magazine Website titles (excluding Foreign and Specialist titles, and Premium Magazine titles)
- 13 pence for all Foreign Newspaper and Foreign Newspaper Websites titles, Specialist and Specialist Website titles
- 13 pence for all Premium Magazine and Premium Magazine Websites titles

Subject to a Minimum Monthly Fee payable of:

- £455 if over 350 Copies are made per month
- £239 if under 350 Copies are made per month
- £64 if only Magazine content is copied if over 190 copies are made per month
- £34 if only Magazine content is copied if under 190 copies are made per month

### 2. SCANNING FEE / ELECTRONIC LICENCE

If you exercise the rights licensed in Clauses 1.2 or 1.3 of the Paper Licence and/or Clauses 1.1 or 1.2 of Electronic Licence a monthly scanning charge will apply based on your total number of Clients. The fee charged will be:

- 31 pence for Premium Magazine titles and Specialist Titles
- 31 pence for all Foreign titles

#### 6. Scanning Fee / Electronic Licence Fee Reduction

If you subscribe to a MMO Database Licence then the charge for the Electronic Licence will be reduced – details on application.

#### 7. Audit Fee

A fee is payable to cover audit costs as follows:

#### 8. Default Charge

For each day's default in delivering the return in accordance with section 3.1 of the Paper Licence and/or section 5.2 of the Electronic Licence and/or section 13.4 of the Database Licence NLA may charge as liquidated damages to compensate us for our additional administrative effort a fee of £25 per day.

#### 9. Renewal Fee

Where a Licence has been terminated by the NLA pursuant to clause 3.2.3 of the MMO Licence, a renewal fee may be charged for a new licence as follows:
